EXECUTIVE SUMMARY

The purpose of this deliverable is to establish the knowledge and IPR management procedures for AUTOFLEX, which is based on Horizon Europe IP Management guidelines and the project Consortium Agreement, as well as (Model) Grant Agreement.

This deliverable revisit the background and foreground procedures listed in the Consortium Agreement, including a mandatory Results Ownership List (ROL). Related to the ROL a suggested Innovation Disclosure Form template is presented and the partners are urged to utilise it in case of any patenting processes.
